

OUR IMPACT

Two of our elderly residents, a husband and wife, developed serious health issues and are no longer able to work. Although they now receive Social Security disability benefits, they have trouble making ends meet with increased medical expenses. The Food Shelf provided them with the additional food needed to get through the month. Before, they often skipped meals because they needed to stretch their food supply. Without Food Shelf support, they would likely have more health related issues due to poor or inadequate nutrition. (Lake Benton CS)

"WRAP has been a godsend to me. I started working with WRAP when an advocate, Julie, found me on the side of the road. Since then, WRAP has been a huge part of everything good in my life. They've gotten me into a sex trafficking refugee shelter. They checked in to make sure that I was safe and if there was anything they could help with no matter where I was." (WRAP)

"Heather" is a mother of 4 who was provided emergency shelter in the Refuge program after she lost her housing. She had no earned income at the time she entered the program. With staff advocacy, we were able to help her receive a Section 8 Housing Choice voucher. The voucher and UCAP case management assisted her, which allowed Heather to focus her efforts on finding employment and daycare for her children. Heather is now employed full time and she and her family are thriving. (UCAP)

I currently have a third grader who has been working with me since the beginning of the school year. She was making some progress but not as much as we knew she could or as much as her target needed to be. I am super proud to announce that after all her hard work she finally was able to reach her target score with no errors and she was the happiest little girl in the school that whole day! Seeing how excited they get and how confident they get makes my job so much more worth it! (ServeMN)
